Applicants should have completed three years of competitive rowing for their Club, except in the case of those who have competed in Henley Royal Regatta or Women's Henley Regatta (eliminating races excluded), and those who have represented their country in a national event at a FISA regatta, when two years apply. Applicants should have a minimum of four status points, and be at least 18 years of age.
